1. If the name of any Immediate Lessor who is rated, because the Property does not exceed £4 or £8, as the case may be, is not accurately known, the words "Immediate Lessor" must be entered in this column instead of the name.

2. Before Rating any Immediate Lessor on the above ground, it must be ascertained that the Occupier of the Tenement does not occupy any Rateable Hereditaments *in the Union* of such annual value as to make the whole exceed £4, or if the Rate be for an Electoral Division containing any part of a Borough named in the Schedule to the Act 6 & 7 Victoria, Cap. 92, it must be seen that he does not occupy more than £8 net annual value in that *Electoral Division*; in either of such cases the Occupier of the Tenement, and not the Immediate Lessor, must be rated for it.

3. Care must be taken not to Rate the Immediate Lessor of any Tenement not exceeding £4 or £8, as the case may be, wherein the Occupier has a greater Estate or Interest than a Tenancy from year to year, unless that Interest has been created by any Lease or Agreement made since the passing of the Act (24th August, 1843.) in which latter case the Immediate Lessor must be Rated.

4. Where the Immediate Lessor is rated in virtue of an Agreement with the Guardians, he must be rated by his name.
