Descriptive Particulars.

This Property consists of two parts. The first part comprises the first ten Lots, viz., the Townlands of Ballinamoe, Ballymoylan (part of), Tallasbeg (part of), and Knockanfoilmore, Newtown (part of), Ballyrusheen, Esker, Creggane, Knockannamohilly, Boolaroe, and Ballyvaughan (part of), situate within six statute miles of Nenagh, in the Barony of Owney and Arra, and Parish of Youghalara, close to the Shannon; and the other part consists of Lots 11 and 12, called Ballyoughter and Cooldotia, situate in the Barony of Kilnamanagh and Parish of Moyaliffe, within four miles of Thurles, close to the Demesne of Castle Fogarty.

Said first part consists of arable, meadow, and pasture land. The arable is generally light soil, suitable for grain crops and turnips. The meadow and pasture lands lie contiguous to Youghal Bay, an inlet of the Shannon, and are very valuable.



DESCRIPTIVE PARTICULARS—continued.

As the Limerick and Roscrea Railway now runs through Nenagh, and as the estate is well roaded, there is ample communication with it, both by land and water.

Some of the tenants on this estate are very comfortable and respectable, paying rents varying from £50 to £100 and £150 per annum, and as a general rule, all the rents are paid with punctuality.

The other part, comprising Lots 11 and 12, lies within four miles of the Town of Thurles, in the Barony of Kilnamanagh, as before mentioned.

Ballyoughter lies immediately adjoining the Demesne of Castle Fogarty, and Cooldotia a little distance from it. The land of the former townland is chiefly in pasture and meadow, and is of a very fertile nature.

The houses of the large farmers are generally thatched, though some have good slated offices. They are not of that superior class which might be desired, but they are reasonably comfortable.

The total net rental, it will be observed, is lower than the Government Valuation, and the lands may be considered reasonably let.






