

By Indenture of Lease, dated the 8th of February, 1794, Sir Amyrald Dancer, Baronet, demised unto Owen Keogh the old holding in Modreeny, then lately held by John Power, deceased, situate in the Barony of Lower Ormond, and County of Tipperary, containing one acre, or thereabouts, plantation measure, more or less, TO HOLD from the 1st of November then last for 999 years, at the yearly rent of £5 of the then currency, equal to £4 12s. 4d. present currency, payable half-yearly on the 1st of May and 1st of November.



Descriptive Particulars.

The Lands of Modreeny are of prime quality, all in hand, and have been in grass for a long time past; the greater part of them superior meadow and feeding land. The timber is of great beauty and value. Attached to Lot 2 is an oak wood, about an acre in extent, of considerable value.

A fine trout stream runs through the grounds. The Mansion-house (situate on Lot No. 1), is commodious, and in all respects suitable to a gentleman's family. The offices are extensive and complete, with an excellent walled-in garden.

The pleasure grounds and shrubberies are tastefully laid out, and embrace the interesting ruins of a fine old castle.

Altogether it would be difficult to meet with a more complete and beautiful residence. To be appreciated it should be seen.

Modreeny is situate in a highly improved locality, one mile from the Market and Post Town of Cloughjordan, a Station on the Parsonstown and Nenagh branch of the Great Southern and Western Railway between Nenagh and Roscrea, thus affording rapid communication with Dublin and Limerick. The Parish Church adjoins the demesne. The poor-rates are almost nominal.

The Lands of Ballyhasty are all in grass, much of it feeding and meadow land, and form, with Modreeny, one of the finest grazing farms in the district. These lands, which are beautifully situated and enclosed by a demesne wall, form an important addition to the estate of Modreeny.




