Tipperary Material in Ossory Archives

Fearghus Ó Fearghail

The manuscript collection of Canon William Carrigan which is kept in the archives of St. Kieran's College, Kilkenny, contains some valuable material relevant to Co. Tipperary. Much of it is contained in wills which Carrigan copied because of their relevance to priests or because of a Kilkenny connection. Carrigan was particularly interested in priests' wills and administration bonds of the seventeenth and eighteenth centuries since in the absence of many ecclesiastical records, these provide valuable information especially for parish succession lists. He also combed eighteenth century newspapers and magazines for priests' obituaries, of which he has a great number, and for more general information on people and events. Another useful source for information on the clergy is provided by subscription lists. While he concentrated on his own diocese of Ossory and used much of this information in his history of the diocese, he gathered information on priests of all the Irish dioceses, but particularly on those bordering Ossory. In a number of cases these supplement the information contained in the edition of the Skehan index published in 1993 by the late archbishop of Cashel, Tomás Ó Muiris.

Ossory diocesan archives contains a small number of documents that add to the information on Cashel priests. At Christmas 1792 the newly consecrated Archbishop Bray of Cashel sent a number of Cashel students, some of whom were probably priests, to the new seminary in Kilkenny.⁷ They were among a group of eighteen students, mostly from Cashel and Waterford, who began their ecclesiastical studies at this stage. They joined twelve students who had begun their seminary course the previous September in what was a quiet but historic venture – the provision once again of ecclesiastical studies in Ireland, the first such course in Ireland for many years, a year before Carlow and three years before Maynooth. Indeed the earliest identifiable ordinations from the Kilkenny seminary are of two Cashel students, in 1795 and 1796. The college only has partial lists (prize lists) of those who entered before 1811, but O'Carroll collected the names of some of these students.⁸ The documents in the Ossory Diocesan Archive give a close approximate date of ordination for a number of these and help to fill in lacunae and correct some of the information in Tomás Ó Muiris's invaluable work.

11thly I Leave and bequeath to both my friends Brien Meagher and Redmond Grace, the two best of my horses or mares.

12thly My will and desire is that after those Legassys and debts are paid that all my

goods, Chatles and other parsonall Estate, be divided into three partes, and that my best beloved wife shall have and injoy one parte therof, My Daughter Catheren Lanegan the second parte, and the theird and Last parte, my will and desire is that it be divided twixt my sone John Lanegan, James Lanegan, Valentaine Lanegan and George Lanegan share and share like, and if my sone James Lanegan be not now alive or that he should hapen to die before he should come into the country my will is that my son John Lanegan shall have his share and proportion and that John shall in the mene time receave his share and convart it to the best advantage he can for James use until he comes or knows of his death.

13thly My will and desire is that though I desire my goods, Chattles and other personall Estate should be divided into three equall partes betwixt my wife and children in maner and forme aforesd. yet my will and desire is that none shall be concerned in my farme of Clonegose but my sones John, Vallentaine and George.

Cashel priests ordained in Kilkenny 1796

The first ordination from Burrell's Hall (the founding site of St. Kieran's College) was of John or James Brown (PP Ballylanders, 1809-1839), a native of Clonoulty Hill. According to Fr O'Carroll's notes he studied in Kilkenny. The document which is signed by Thomas Bray and was sent to Bishop Lanigan, bishop of Ossory, grants permission to receive orders. It is dated 1796. Ordination usually followed quickly, and indeed Brown is found as CC in the Thurles Conference area from August 1796, suggesting that he was probably ordained priest in May or June and in the Tipperary Conference area from 05/1808, probably as CC Galbally (Bray's Conference Lists, C & E Archives). He died 19/06/1839, aged 88, and was buried in Clonoulty churchyard.

Philip Cleary, PP Ballybricken, 1814-46, a native of Rathduff, Golden, born 24/12/1781, studied in Kilkenny according to Fr Carroll's notes and was ordained there in 08/10/1806, by the bishop of Ossory, Dr. James Lanigan, Bp. A document in the Ossory Diocesan Archive confirms this.
